### Greenbush Golf Course Membership Terms

**I. CONDITIONS OF MEMBERSHIP**  
Membership is open to any individual without regard to race, sex, ethnic background or religion. All applications for membership are subject to approval by Greenbush Golf Course which shall have sole discretion to approve or reject applicants. All members will be issued a 2009 membership card when payment is made in full. This card identifies themselves as a member and as authorization to make "On Account" charges to Corporate Account Packages. Membership also entitles the member to the use of specified facilities during normal hours of operation. The sale of memberships are subject to their availability and are subject to change. All memberships are non-refundable.

**II. DUES**  
The obligation to pay dues is not dependent upon the availability or the member's use of all the Club's facilities. Repairs, improvements, emergencies, events, etc. may require the restriction or closing of some or all areas from time to time. Dues will not be suspended or refunded during the time when certain facilities are not available. Greenbush Golf Course will make reasonable efforts to ensure that all areas of the operation are in suitable operating condition at all times. All membership fees paid on or after April 15, 2009 are due in full at the time of payment. Partial membership payments made prior to the above are due in full on April 15, 2009. All membership fees must be paid in cash or check.

**III. TERM OF MEMBERSHIP**  
The membership begins on the date purchased and runs through the 2009 golf season. Memberships run continuously, and no temporary suspensions are allowed because of travel schedules or personal needs. Memberships may be purchased at any point in a season, but no discounts are provided based on how late in the season the membership is purchased. All memberships, no matter the purchase date, expire at the conclusion of each calendar year.

**IV. SUSPENSION OR TERMINATION OF MEMBERSHIP**  
Management has the right to immediately suspend and/or terminate any membership for non-payment of dues, rules violations, or for behavior that may diminish the enjoyment of the Greenbush Golf Course for other members.

**V. TRANSFERRING/CANCELLING MEMBERSHIPS**  
Memberships are non-transferrable and non-refundable. If a family moves from the area, a membership rebate may be given according to the following circumstances:  
a. Notification in writing by April 30, 2009—a full refund for Dues, less a \$75 processing fee.  
b. Notification in writing by May 31, 2009—half the annual dues refunded.

**VI. TEE TIME POLICY**  
All members must check in with the starter in the Pro Shop prior to playing a round of golf on any given day. This policy is to ensure member identification and the course's speed of play at all times.

**VII. LIABILITY/WAIVER OF CLAIMS**  
a. It is expressly agreed that all use of the facilities' equipment and programs shall be undertaken by a member or guest at his/her sole risk, and Greenbush Golf Course shall not be liable for any injuries or any damage to any member or guest, or be subject to any claim, demand, injury or damages whatever, including, without limitation, those damages resulting from acts of active or passive negligence on the part of Greenbush Golf Course, its owners, employees, officers or agents. The member, for himself or herself, and on behalf of his or her executors, administrators and assignees does hereby expressly forever release and discharge Greenbush Golf Course, its successors and assignees, as well as its owners, officers or agents for all such claims, demands, injuries, damages, actions or causes of action.  
b. It is expressly agreed that Greenbush Golf Course shall not be responsible or liable to members or their guests for articles lost or stolen at the Course. Greenbush Golf Course also shall not be liable for loss or damage to any other property of members or their guests, including their automobiles and contents therein.

**VIII. OTHER**  
a. Greenbush Golf Course reserves the right to close the facility for private functions.  
b. The Greenbush Golf Course terms, contained herein are not inclusive. Changes, deletions, or additions to course terms, rules and regulations, fees and dues may be made from time to time by course management. Members are required to abide by these changes.
